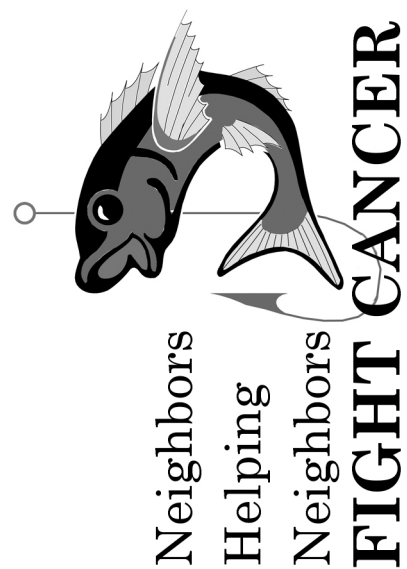

**Neighbors Helping
 Neighbors Fight Cancer**

The Greater Atlantic Bluefish Tournament (GABT), now in its 29th year, was started by a group of local fishermen, mostly members of the Absecon Saltwater Sportsmen, as a way to raise money to aid cancer patients in need. At that time, we became affiliated with a national cancer aid group. However, in an effort for funds raised to be used for local cancer patients, we, in 2003 applied for and were awarded our own 501-(C) (3) charity status and adopted the “Neighbors Helping Neighbors Fight Cancer” agenda. We are a fully registered not profit charity, all volunteer organization with no paid workers. Funds for the organization are derived primarily through individual and corporate contributions, as well as entry fees from the tournament. Due to the ever increasing request for financial assistance from local cancer patients, we have added additional fund raising events, including raffles, dollar donation program and a very successful “Chinese style” gift auction.

We are committed to continue our “Neighbors Helping Neighbors Fight Cancer” program in the southern New Jersey area. We provide assistance and direct grants to patients in need to help with insurance co-pays, medications, rent, weekly bills and other expenses associated with their debilitating illness. Our mission is to help them through their difficult time. Since becoming our own charity, we have helped over 425 local families with grants, depending upon individual needs, from \$250.00 to \$6,500.00. We also offer an annual scholarship to a deserving radiological student at Shore Medical Center.

To better identify our mission, we have changed our corporate name to “Greater Atlantic Cancer Fund Inc.” (GACF). The tournament remains the same as usual.
